In accordance with the provisions of Practice Direction No 2 of 2022 issued by the Registrar of Companies pursuant to section 12(8) of the Companies Act 2001, and as an environment-friendly initiative, the Company has elected not to send a copy of the annual report to the shareholder until such time that the shareholder makes a request to receive a copy. Moreover, even if a shareholder has given his/her consent to receive annual report in electronic format, the shareholder shall retain his/her rights to receive a copy of the annual report at any time upon request.
