COMMUNIQUE

The Board of Directors of Bloomage Ltd ("Bloomage") wishes to inform the public in general that Bloomage made a voluntary offer on 30 March 2026 to acquire all the shares of BlueLife Limited ("BLL") at an offer price of Rs 0.75 per share (the "Offer") pursuant to the Securities (Takeover) Rules 2010.
