### **TRADING STATEMENT IN RESPECT OF THE FINANCIAL RESULTS FOR THE SIX MONTHS ENDED 31 AUGUST 2021**

In terms of the JSE Limited Listings Requirements, a listed company is required to publish a trading statement as soon as it becomes reasonably certain that the financial results for the next period to be reported on will differ by 20% or more from the financial results for the previous corresponding period.

PSG Konsult hereby advises that a reasonable degree of certainty exists that for the six months ended 31 August 2021<sup>1</sup>:

- recurring headline earnings per share will be between 30.4 cents and 30.8 cents, being between 23% and 24%, higher than the 24.8 cents reported for the six months ended 31 August 2020;
- recurring headline earnings per share excluding amortisation will be between 32.9 cents and 33.3 cents, being between 22% and 23%, higher than the 27.0 cents reported for the six months ended 31 August 2020;
- headline earnings per share will be between 30.4 cents and 30.8 cents, being between 25% and 27%, higher than the 24.2 cents reported for the six months ended 31 August 2020; and
- attributable earnings per share will be between 30.4 cents and 30.8 cents, being between 25% and 27%, higher than the 24.3 cents reported for the six months ended 31 August 2020.

The above per share figures for the six months ended 31 August 2021 are approximately 30% higher than the corresponding earnings items for the most recent pre-COVID interim period ended 31 August 2019.

Recurring headline earnings per share increased by a smaller margin than headline and attributable earnings per share due to the prior period non-recurring R10 million (R7.2 million net of tax) donation to the South African Solidarity Fund in April 2020.

The financial information on which this trading statement is based has not been reviewed or reported on by PSG Konsult's auditor.

PSG Konsult's financial results for the six months ended 31 August 2021 are expected to be published on or about Thursday, 7 October 2021.
