

## SHORT FORM AMALGAMATION

Compagnie Immobilière Ltée ("CIL" or "the Company") hereby wishes to inform its shareholders and the public in general that the Company is considering a 'short form amalgamation' of Multi Channel Retail Ltd ("MCR"), its wholly-owned subsidiary, into the Company.
