

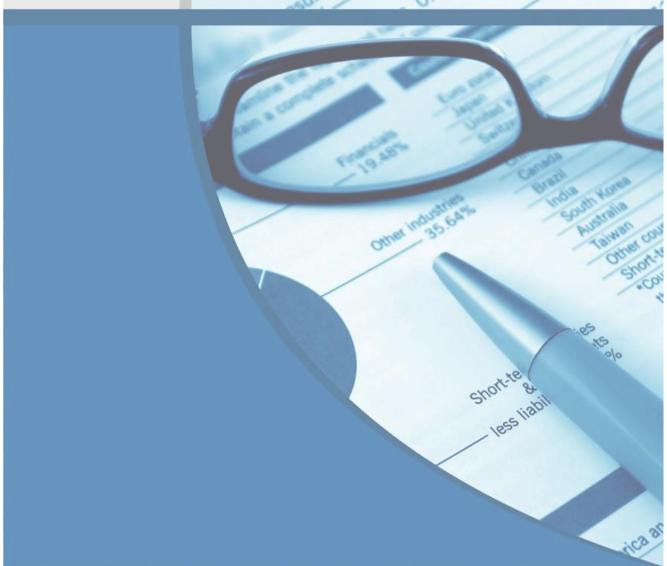

Sumer state (Sumer discretionary 9.12%)



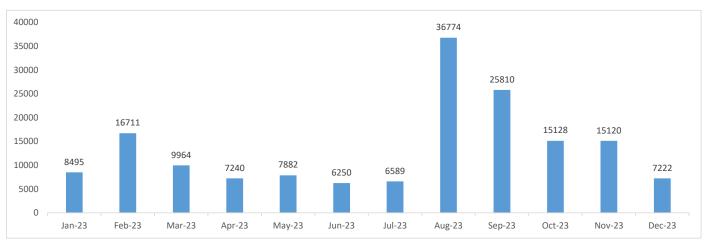
